## A Clear and Direct Message from the Membership

A key action for growth and improvement of the MIAA was to provide clarity to the membership leading to consistent implementation of the rules and regulations set forth by the membership.

The execution of this plan entailed constitutional revisions of the MIAA and the Massachusetts Interscholastic Athletic Council (MIAC). The MIAC was created in 1950. Its constitution was separate and independent of the MIAA. The first step in this initiative was that the MIAC needed to vote to approve its own constitutional revision.

On January 25, 2023, an MIAC/MIAA Working Group was convened to discuss how to delineate clear lines of absolute and advisory authority of the association. The proposal was to re-define the roles of the MIAC by validating their role as members of the Eligibility Appeals Board (EAB), and their ability to review, amend or propose new rules pertaining to the regulation and administration of athletics, in an advisory capacity only.

On January 31, 2023, the MIAC voted unanimously (10-0) to replace their current constitution with new language defining their new role. On February 8, 2023, the MIAA Board of Directors voted unanimously to recommend these revisions to the Assembly (the legislative body ultimately responsible for voting constitutional revisions). On April 6, 2023, the Assembly voted unanimously to enact this significant regulatory revision to the MIAA constitution. In doing so, the Board of Directors is now the final regulatory authority in the rule change process.

The successful codification of the organizational structure of the MIAA that provides clear roles and responsibilities leading to consistent implementation of the rules and regulations set forth by the membership was approved unanimously by the collective voice of the membership. A clear and direct message was delivered throughout the association to consistently apply and act upon the rules and regulations set forth by the membership with fidelity.

#### Fall 2023 Power Rankings

The first Power Rankings for Fall 2023 sports – Field Hockey, Football, Boys and Girls Soccer, and Girls Volleyball -- will be released and published on the <u>Tournament Central</u> section of the MIAA web site on Friday, September 29.

Athletic directors are asked to make sure their schedules and results are accurate and up to date on Arbiter on a nightly basis throughout the school year. The power rankings and tournament seedings depend on complete and accurate data from all MIAA schools.

Beginning in October, updated power rankings will be published on the MIAA web site every Tuesday and Friday throughout the remainder of the Fall 2023 regular season.

#### Soccer Infraction Reporting

All varsity soccer infractions (yellow cards and red cards) must be submitted via the online <u>Soccer Infraction</u> <u>Reporting Form</u> following each game. The home school athletic director is required to submit this information. Sub-varsity should not be reported through this online system. Please note – when a red card is issued, the new student/coach disqualification forms referenced in this newsletter must also be emailed to Donna Harrington at <u>dharrington@miaa.net</u>. The MIAA Soccer and Sportsmanship Committee appreciate the assistance and attention to detail of member schools when submitting this required information.

#### NEW Student and Coach Disqualification Forms

Please make sure that the new <u>MIAA Student Contest</u> <u>Disqualification Form</u> and <u>MIAA Coach Contest</u> <u>Disqualification Form</u> are available at each contest site and discard any previous versions of these forms. When a student or coach is disqualified from a contest, these forms must be completed by the game official and submitted to the athletic director in charge of the contest, or designee, before leaving the site. Please reference <u>MIAA Handbook</u> <u>Rule 49</u> for additional school requirements when a student or coach is disqualified from a contest.
