### Fall 2022 Power Rankings

The first Power Rankings for Fall 2022 sports will be released and published on the <u>Tournament Central</u> <u>section of the MIAA web site</u> on Friday, September 30. Athletic directors are asked to make sure their schedules and results are accurate and up to date on Arbiter by the end of the night Thursday, and on a nightly basis throughout the school year. The power rankings and tournament seedings depend on complete and accurate data from all MIAA schools. Beginning in October, the intention is to have updated power rankings on the MIAA web site every Tuesday and Friday throughout the remainder of the Fall 2022 regular season.

#### **Board of Directors Actions**

**Welcome New Member** – Liz Legault, Superintendent of East Bridgewater Public Schools

**Endowment Fund Scholarships** – The MIAA Board of Directors voted unanimously to set an amount not to exceed \$20,000.00 for the purposes of providing student scholarships for two students per month for a total of nine months at a figure of \$1,000.00 per student and for any special requests from member schools.

**Online Ticketing** - The Finance Committee recommended to the Board of Directors that for MIAA State Tournament contests, in order for an MIAA member school to host the event, they must implement on-line ticketing. This will become a part of the Intent to Enter Form for the MIAA State Tournament. Voted unanimously to approve.

**Hockey Suspension Rule** – The MIAA Board of Directors voted in favor suspend rule (72.12) for the 2022-2023 school year and allow the rule to proceed through the rule change process based on conflicting language in the MIAA Handbook Ice Hockey Rules.

#### Alignments

Proposed Fall 2023-Fall 2024 alignments, along with the associated appeal process timeline, appeal request form, and additional information is to be released no later than October 3, 2022. Factors (including co-op and vocational) have been removed with the exception of private schools bumping up a division.

### **Cooperative Team/Middle Level Waivers**

This fall, some schools applied for Coop's/ML waivers after the deadline of the first contest. The DAC's were forced to permit some flexibility for this fall but ask that schools are attentive to the new requirements and protocols. Coop's and ML waivers cannot be applied for after the first day of competition in each season. For this upcoming winter season that date is Dec. 8, 2022 and the spring date is March 30, 2023. ## **MIAA Committee Highlights**

**Golf Committee** – September 13, 2022 Members of the Golf Committee met to discuss a variety of topics including the 2022 Fall tournaments, live scoring, the possible use of GHIN for future tournament qualifying purposes, as well as a potential rule change proposal that requires all leagues to use stroke play for regular season matches. A sub-committee will be put together to explore most of these topics.

#### **TMC** – September 14, 2022

2022 Winter Tournament Formats were approved by TMC. The committee voted to remove COVID-related language from all formats, including previously approved Fall 2022 formats.

The <u>Statewide Tournament FAQ</u> 2022-2023 document was reviewed, discussed and revised for membership.

Upcoming Alignment Cycle - The committee was given an update on the upcoming alignment cycle (2023-25). Jared Shannon, Sean Mackin, Chicopee Athletic Director and Craig Antocci, Fitchburg Athletic Director presented to the MIAA Board of Directors regarding the new alignments, including removal of co-op and vocational school alignment factors (private school factor remains in place) and use of the Competitive Equity Tool (CET). The committee recognized there is still more to be done in the area of alignments but this recent work represents a positive step forward.

Statewide Tournament - Initial feedback on the first year of the tournament structure is being compiled. The committee discussed consideration of a Statewide Tournament survey to the membership later this fall.

**Soccer Committee** – September 15, 2022 The Soccer Committee met and elected Bob Keuther, Principal of Marshfield High School as the Chairperson and Danny Erickson, Athletic Director at Canton High School, Vice Chairperson. Also, Mr. Jeff Newhall, Athletic Director at St. Mary's of Lynn, has been selected as the Boys and Girls Soccer Tournament Director.

**Football Committee** – September 15, 2022 Medical Personnel was updated in the 2022-2023 Format to reflect current requirements for each team at all games, home and away. Additionally it was also mentioned that a reminder be sent to schools if they wish to opt. out of the non-playoff scheduling/brackets.

Steve Dembowski presented a Coaches' Association proposal to alter the playoff format. That proposal will be linked from the MIAA Football page when finalized.

**Swim Committee** – September 16, 2022 Discussion on making sure times in the formats were upto-date and ready for publication. All had been previously approved but some of the qualifying times were incorrect in the first published version. Current posted Fall 2022 format is correct. The dates for the Voluntary Dive Weeks submitted by coach's representative Mike Foley were approved. They will be posted on the Swimming and Diving page of the MIAA website.

**Ice Hockey Committee** – September 21, 2022 2024 tournament cutoff dates. There had been discussion of moving the cutoff date to allow for power ranking or other planning. After some discussion the committee motioned to stay with the same, Thursday cutoff date. MSHCA wanted to make all member school teams aware of the various awards offered by MSHCA – academic awards and Mulloy Sportsmanship to name a few. Annual Ice Hockey Officials Summit is scheduled for October 11, 2022.

Lacrosse Committee – September 21, 2022

A major change for the upcoming season is that it will be mandatory that your center line must be a full line across the field. This means that if you have a center logo and your centerline is not constant through the logo, you will need to ensure you have a line that goes from sideline to sideline. You can do this with a chalk line that goes away in a few days or you can fully paint a line through your logo. If this is not done, the visiting team will start with possession. **Track & Field Committee -** September 21, 2022. Indoor track format was reviewed and an updated schedule/formatting was approved. During the discussion, two motions were made and approved, which will be in effect this season: The 300m dash will be run in lanes and late entries will no longer be accepted for indoor and outdoor tournaments.

The committee took advisory votes on cross country, indoor and outdoor track 2023-25 alignments – all voted to approve.

## **Educational Athletics**

**Student Advisory Committee** – September 21, 2022 The MIAA Student Advisory Committee met in Franklin to set goals for the year and participate in facilitator training. They also met with Fabiola Brunache who talked with them about financial literacy and challenged them to think of ways to incorporate this topic in future student workshops. Finally, the students elected their committee leadership team, Story Goldman (Smith Academy), Madison Carini (Abington) and Jake Barlow (Minnechaug). #### Sportsmanship Committee – September 21, 2022

The Sportsmanship Committee reviewed plans for the annual Sportsmanship Summit that is scheduled on Thursday, November 10 at Gillette Stadium. A subcommittee will be meeting on Friday, October 14 to select the winning entries for the Student Sportsmanship Essay/Multimedia Contest. The committee also reviewed the annual contest disqualification data for the 2021-22 school year and will continue to monitor trends across each sport.
