Tournament Entry - Opt-in vs Opt-out

Schools no longer are required to submit a tournament entry. Schools will be required to submit communication if choosing to opt out of tournament play. This new process is only for sports that utilize the MIAA power ranking system. Hybrid sports will continue to require a tournament entry process. Click here to complete the "Opt-Out" Form (located in the Members Only area of the MIAA website).

Forfeit / No Contest Determination

Member Schools with any unplayed Spring 2025 contests must submit the TMC Determination Request Form at the link below to request a determination of "Forfeit" or "No Contest". Complete all sections of the form thoroughly. This information will be reviewed by a Seasonal Seeding Committee consisting of the chair or designee from each in-season sport and TMC representatives. Tournament Directors and Executive Liaisons may be present but are non-voting members. All decisions made by the Seasonal Seeding Committee are final. Once a determination is made, it will be shared with the schools included on this form. Every attempt should be made to reschedule the contest on the next available date.

NOTE: This <u>form</u> does not need to be filed in the case of forfeits due to a canceled season (Rule 18), over scheduling (Rule 34.6), or ineligible player (Rule 86). (Password can be found on your School Admin Dashboard in the Members Only area of the MIAA website.)

Outdoor Track

Reminder – Tournament entry deadline is May 24 – Pentathlon and May 26 – all other entries.

At the most recent Cross Country and Track Committee meeting, it was recommended that schools take this opportunity to inspect their horizontal jump pits, ensuring they contain a sufficient amount of sand and that the surface is level to help prevent potential injuries for future events and seasons.

Student and Coach Contest Disqualification Forms

Please make sure to use the most up-to-date version of the MIAA Student and Coach Contest Disqualification Forms. The forms are available in the "Officials" section of the MIAA website. When a student or coach is disqualified from a contest, the required form must be completed by the game official and submitted to the athletic director in charge of the contest before leaving the site. "Extra Week" - Fall 2025 Football

Although most fall football schedules are probably completed, please accept this as a reminder of the football "extra week" in the Fall of 2025. Labor Day is early, 9/1/25 and Thanksgiving is late, 11/27/25 (this is the second year in a row of this occurrence). As has been the case in the past, this creates an extra weekend in the qualifying period before the beginning of the state tournament. The extra week is labeled "1A". Schools can schedule a maximum of 8 games in the 9-week period between Labor Day and the cutoff date of Saturday, 11/1/25. More detailed information can be found at this link.
