#### 2025 Schedule Commitment Deadline & Process

With practices and tryouts for Fall 2025 sports now under way, this is a reminder that the MIAA schedule commitment deadline is Friday, September 12. All schedules for **Field Hockey, Football, Fall Golf, Soccer, and Fall Volleyball** must be entered into Arbiter by the end of the day on September 12.

After that point, no changes can be made to your opponents or the number of games/matches that can be played. After the September 12 commitment deadline, all schedules will be considered **FINAL**. Three days before the Schedule Commitment deadline, MIAA staff will produce and publish schedules for each sport based on the available data for review and verification by member schools. Below is the breakdown for 2025-26 school year:

- FALL 2025
  - o First contest date: Sunday, August 31 (Friday, August 22 for Fall Golf)
  - o Schedule data published for review: Tuesday,
  - o Schedule Commitment deadline: Friday,
- September 12
   WINTER 2025-2026
  - o First contest date: Thursday, December 11
  - o Schedule data published for review: Tuesday,
  - December 16
  - o Schedule Commitment deadline: Friday,
  - December 19
- SPRING 2026
  - o First contest date: Thursday, March 26 (Monday, March 23 for Spring Golf)
  - o Schedule data published for review: Tuesday,
  - o Schedule Commitment deadline: Friday, April 3

Check the <u>MIAA Sport Limitations Information Sheet</u> for the maximum number of competitions allowed per week and per season in each sport.

## **In Support of Game Officials**

The MIAA acknowledges the persistent and growing shortage of game officials. This shortage is impacting schools and communities in several significant ways:

- Current officials are overburdened, leading to burnout, overuse, and attrition.
- Many contests, particularly at the sub-varsity level, proceed with fewer officials than recommended (e.g., only one official for baseball, softball, or soccer games that typically require two).
- Games are being scheduled on less desirable days and times, affecting practice routines and creating conflicts for student-athletes, coaches, and families.
- Some games, especially at the sub-varsity level, are being postponed or cancelled due to lack of officials.

While the MIAA does not directly oversee the recruitment or training of game officials, we remain committed to supporting our member schools in addressing this ongoing issue. To support our member schools' efforts in this important area, the MIAA is expanding and enhancing its energies with our strategic partner **RefReps**.

Together, we aim to facilitate access to the knowledge and skills needed to serve as game officials—creating a sustainable pipeline of future referees.

## How MIAA Will Support Member Schools Using RefReps:

- Provisional Certification: Students who complete
  a RefReps course will be registered with the MIAA
  as provisionally certified officials. These students
  may be assigned to work sub-varsity (middle
  school, freshman, JV, and youth league) games
  under the guidance of veteran officials.
- Grant Program for Seat Licenses: The MIAA will facilitate a grant program offering 200 seat licenses to MIAA member schools. These licenses will support the launch of school-based officiating training programs.
  - Grant details and application instructions will be released no later than August 31, 2025.
- Pathways to Employment and Skill
   Development: Students trained through RefReps can earn money while officiating, all while developing valuable employability and leadership skills.

We invite all MIAA member schools to explore this opportunity to support student development while helping resolve the officiating shortage in our state. Together, we can build a stronger foundation for the future of high school athletics.

## MIAA Statewide Tournament Host Fee Update Baseball, Field Hockey, Lacrosse, Soccer, Softball, and Volleyball:

Beginning with the 2025-2026 school year, the Round of 16 games for Field Hockey, Lacrosse, Soccer, and Volleyball, expenses and revenue will remain with the host school. As a reminder, the Round of 16 games for Baseball, Rugby, and Softball were previously being managed under this same policy.

MIAA tickets will be sold beginning with the Round of 8 through the State Finals. The host school will be paid a set tournament hosting fee for each event.

## Football, Basketball and Ice Hockey:

MIAA tickets will be sold beginning with the Round of 16 through the State Finals. The host school will be paid a set tournament hosting fee for each event.

For rounds in which the MIAA sells tickets, custodial and police details will be paid separately by MIAA and must be included on the Tournament Host Site Form. This form is required to be submitted by the host school upon completion of the event.

## **Student Eligibility Waiver Deadlines**

As a reminder, below are the seasonal deadlines for student eligibility waiver submissions as outlined in MIAA rule 87.1. These are firm deadlines and late waivers will not be accepted.

- o Fall September 22, 2025
- o Winter December 15, 2025
- o Spring April 1, 2026

## **Coop & Middle Level Waiver Applications**

Middle Level waivers and Coop Applications cannot be applied for after the Schedule and Commitment Deadline for each season. The final application date for Fall sports is **September 12, 2025**.

#### Golf

The MIAA golf committee voted last February to adopt and implement a maximum score policy for the postseason beginning this fall. The policy is outlined on page 3 of the Golf Format <a href="https://www.miaa.net/sites/default/files/2025-06/golf-fall-2025.pdf">https://www.miaa.net/sites/default/files/2025-06/golf-fall-2025.pdf</a>.

- NEW Maximum Score Policy Double Par + One Stroke. Par 3's max score of 7, Par 4's max score of 9, Par 5's -max score of 11.
- Golfers are not required to play the maximum number of strokes on a hole before picking up. They may pick up at any point during the hole and take the maximum score for that hole.

As for postseason dates, see below:

- Sectionals: Either Tuesday, October 14th or Wednesday, October 15th
- States: Monday, October 20<sup>th</sup>
- New England's: Sunday October 26 and Monday October 27.

#### Soccer

There has been much discussion, from both referees and coaches, regarding the "shin guard rule' and expectations of the enforcement of this rule. As with any rule, it is the expectation that we as an Association follow the NFHS rule and support the officials in its enforcement.

The NFHS guidelines regarding shinguards is as follow.

- 1. Professionally manufactured.
- 2. Age- and size-appropriate.
- 3. Worn under socks.
- 4. Worn with bottom edge no higher than 2 inches above the ankle.
- Must meet NOCSAE Standards at time of manufacture.
- 6. NOCSAE seal and height range permanently marked on front of shinguard.
- 7. May not be altered.

The MIAA Soccer committee believes that high school students wearing "micro-guards" are in violation of the above rule. Shinguards must be a reasonable size and cover more of the shin than a "micro-guard." The MIAA expects that coaches will continue to be responsible for their student athletes wearing reasonably sized shinguards. Game officials are NOT expected to do a shinguard check prior to games but should continue to ask coaches if their student athletes are properly equipped as part of the pregame process. If a game official observes a player wearing "micro-guards," it should be handled the same as if a player is improperly equipped for other reasons (jewelry, etc.). We thank everyone in advance for their attention to this matter and wish you a successful season.

#### "Extra Week" - Fall 2025 Football

Although most fall football schedules are probably completed, please accept this as a reminder of the football "extra week" in the Fall of 2025. Labor Day is early, 9/1/25 and Thanksgiving is late, 11/27/25 (this is the second year in a row of this occurrence). As has been the case in the past, this creates an extra weekend in the qualifying period before the beginning of the state tournament. The extra week is labeled "1A". Schools can schedule a maximum of 8 games in the 9-week period between Labor Day and the cutoff date of Saturday, 11/1/25. More detailed information can be found at this link.

The Massachusetts Interscholastic Athletic Association is proud to announce that the Harry Agganis Student-Athlete of the Year Award recipients for 2024-2025 are Ainsley Kearney of West Springfield High School and Lucas Andrade of Brockton High School. Ainsley and Lucas exemplify the true meaning of successful student-athletes as they are great leaders and teammates as well as involved community members. The MIAA continued partnership with the Agganis Foundation promotes student-athletes and celebrate those that best represent the qualities for which the award is named, Harry Agganis. Considered by many to be the greatest athlete to come out of the state of Massachusetts and a native of Lynn, Harry was born on April 20, 1929, to Greek immigrant parents. He later starred in football, basketball, and baseball at Lynn Classical High School. He played college football at Boston University, where he was named an All-American and was

inducted into the school's Hall of Fame. Although having options to play professional football and baseball, Harry chose to play baseball for the Boston Red Sox, becoming a fan favorite before his tragic death of a pulmonary embolism at the age of 26.
