  - Schools play like size schools, path to the championships is equal, same format across the state, one seeding and qualifying method for all divisions, allows teams to play if in the same division not geographically, pulls schools and ADs together to appreciate all communities, rankings coming out every week created excitement for all sports
  - One piece of data 54% increase in attendance at volleyball state games
