- 1. Minutes of March 12, 2025 Approved
- 2. Finance Committee report
 - a. FY26 budget is built to result in a zero balance budget.
 - b. Defined Benefits Will be terminated on October 1, 2025 based on 3rd amendment. Will take about 1 ½ years to official close. Approved unanimously
 - c. March financials were reviewed winter tournament finals are not completed as of this meeting
