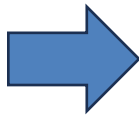
COACHES REGISTRATION:

Coaches Directions



Coaches must have an account register with their high school for their team to register for the NE Meet. Coaches may only enter a performance from their State Association Championship event that is designated as their State's New England Championship qualifier. Each State Association Championship event that is designated as their New England Championship qualifier event, will have those results linked to www.athletic.net. Coaches may only use the performance achieved at your State Association Championship event that is designated as your New England Championship qualifier. Do not alter/convert your athlete's time/distance. All entries must be approved by your respective State Association Representative.

Deadline Monday, June 8th (12-Noon)

Coaches will receive an email notification that their entry has been accepted when entered.

A team will not be charged unless accepted. **All registration fees must be paid ONLINE prior to the meet.** There are no refunds. **Entry fee \$20 per athlete**, this includes alternates in the relays. Wristbands will be issued for admission into the **William R. Bourbon Stadium** for all athletes entered.

(Note: Only team members listed on the entry submission and two coaches will be allowed through the competitor gate. Coaches or Athletic Directors passes will not be accepted at this meet.

Para Athletes: Para athletes who competed in their respective state associations' state championship, will be permitted to enter in the New England Championship in the event (s) they participated in at their respective State Association Championship event that is designated as their New England Championship qualifier event. Para entries are in addition to the current entry limit for each state. The selection of athletes will be made by each state's Association Track Committee.

Entry Limit: No athlete may compete in more than 4 events including relays. **Individual state participation rules apply.** Each state will be allowed 6 entries per event. All qualifiers must have participated in the finals at their respective state associations' event that is designated as their New England Championship qualifier event. Qualifying performances for seeding must also come from their respective state associations' event that is designated as their New England Championship qualifier event..

Packet Pick up: Will begin at 8:00 am and remain open until noon. Packet Pick up will be near the Athlete/Coach entrance on the west side of the track.

School Reps: All competitors must have an official school representative present in order to compete and must remain at the championship site throughout the meet. If it is a parent, a letter stating such on school letterhead and signed by either the school Principal or AD must be submitted at Packet Pickup.

Admission: **We will only be using ONLINE TICKETS** and there will be **no cash accepted at the gate.** \$10.00 general admission, spectator gate will open at 8:30 AM. The online ticket link is <https://gofan.co/event/3548771?schoolId=CNESSPA>

Order of Events

Field Events: Girls Pole Vault will begin at **9:00am** followed by Boys Pole Vault
All other Field events will begin at **10:00 am**.

Long Jump: 2 pits – 10:00 am Boys and Girls at the same time followed by the Triple Jump

Pole Vault: 1 pit – **9:00 am** Girls followed by Boys

High Jump: 10:00 am Boys followed by Girls

Shot Put: 10:00 am Boys followed by Girls

Discus: 10:00 am Girls followed by Boys

Javelin: 10:00 am Girls followed by Boys

Running Events: Running events will begin at **10:30 am**.

Girls first except 100m/110m hurdles finals.

NOTE: Fastest sections will be run last. All athletes must check in to their events at the **clerking area by start line outside of track** upon the **FIRST & ONLY CALL** of their event. This will be approximately **TWO FULL EVENTS PRIOR** to their event. Do not miss the check in. In the 100/110 m High Hurdles and 100 m Dash, the top 8 times will advance to the final.

Awards: Plaques will be awarded for first place and medals will be awarded for second through sixth place in all events. All Awards will be announced and then presented to the recipients at the Awards Tent located under the Stadium Bleachers. A New England Commemorative Pin and a Certificate of Participation will be awarded to every competitor and can be found in the coaches packet at packet pick up.

**William R. Bourbon
Stadium:**

Concessions and lavatory facilities will be available. No locker rooms will be available. Spikes 1/4" pyramids or smaller. Only officials and competing athletes will be allowed inside the track area. **NOTE:** The javelin throwing area is located outside of the Stadium. The javelin runway surface is a grass surface. Blocks will be provided, but athletes may use their own. Teams are responsible for team equipment and personal items. Neither the facility, meet management, nor CNESSPA assume any responsibility for lost or stolen items. Teams should monitor their own areas.

Equipment: All equipment must pass inspection at the meet according to National Federation Rules, and the approved shot, javelin and discus must be made available to any competitor. All implements will be inspected in the garage near the start/finish area. Athletes using non-certified equipment will be disqualified. Implements will be weighed beginning at 8:45AM. Priority will be given to events starting at 10:00AM. You may bring your own blocks. Batons will not be provided.

Pole Vault: ****Every coach of an athlete competing in the pole vault must submit a weight certification form signed by a school official to the pole vault official prior to the warm-up period.** ** (Please use the form included in this packet or a similar state approved form.) The “5 alive” format will be used. The opening height in the girls Pole Vault will be 9’0” and boys Pole Vault will be 12’6” both will go up 9 inches after the opening height and then go up 6 inches at time (see below). An area will be provided for a designated coach for the pole vault.

High Jump: The opening height in the girls High Jump will be 5’0” and boys High Jump will be 6’0”. Both will go up 3 inches after the opening height and then go up 2 inches at a time (see below). The “5 alive” format will be used.

Field Events: All athletes should check in at the event site. All field events will be arranged so that those with the best qualifying performances will compete in later flights. The top 9 will advance to the final in the Long Jump, Triple Jump, Shot Put, Discus, and Javelin. In the horizontal jumps, all athletes are strongly urged to get a mark BEFORE the event begins. A fair warm-up will be allowed between flights expecting you to have a mark with which to start. In the throwing events, a warm-up will be allowed between flights but it will be controlled.

Starting and successive heights of the crossbar:

Checking Out: Athletes leaving from a field event for a running event must check out with the official of the event. **Athletes should not check out earlier than necessary.**

Check in Running: Athletes checking in for running events must report to the clerk of the meet **TWO FULL EVENTS PRIOR** to their event. **Check-in will be in the area near the start line.** Athletes must stay in the clerking area until they are marched to the start.

- Protests:** The Meet Director will establish a Jury of Appeals consisting of three coaches and two officials whose purpose will be to adjudicate all protests relating to the decisions made by the referee. **A \$20 Fee must accompany any protest.** The judgment of the Jury of Appeals is final.
- Team Tents:** **No Tents in Stands or On the Warm Up Areas.** Please use only grass area next to warm up areas which are marked on the accompanying facility map.
- Locker Rooms:** No locker room facilities will be available. Please come dressed to compete.
- T-Shirts:** Official New England Outdoor Track & Field Championship apparel will be sold at the meet. Apparel can be pre-ordered at <https://www.grrteesmsp.com/> until the Thursday before the Meet and post-ordered beginning on Monday after the Meet.

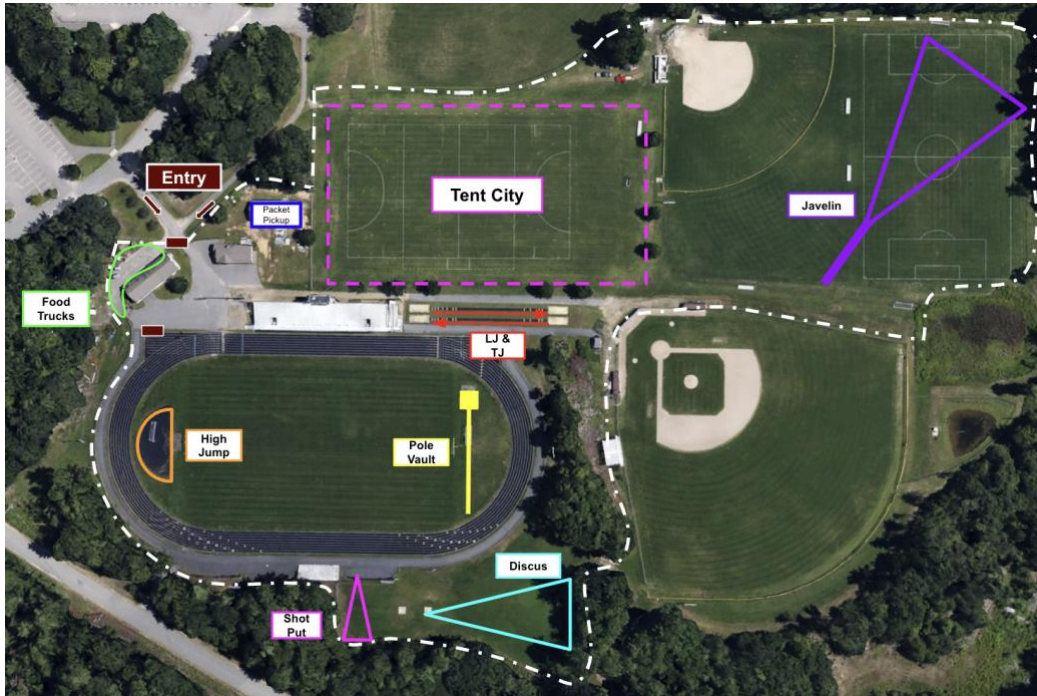

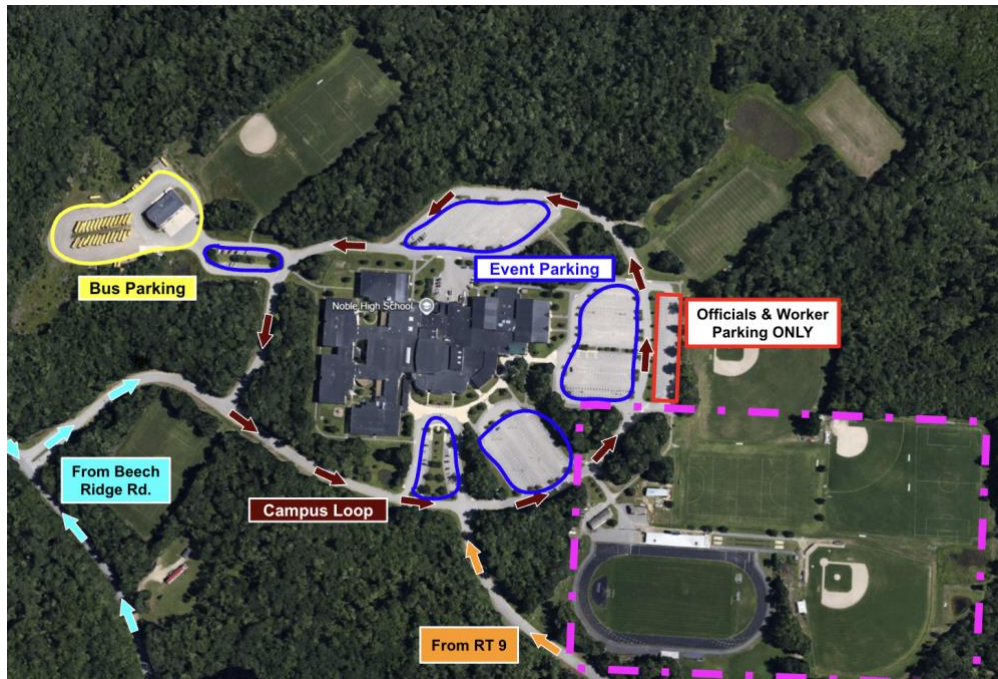
